### 1) Treasure's Report

- Checking = \$3,722.76
- Fisherman's Relief Fund = \$3,033.20

### 2) Misc Business

- The annual DFG jamboree is scheduled for July 25, 2024, however time is unknown. It will be held at the Fish & Wildlife department in San Diego. Tournament dates will be picked for "2025".
